protection of natural persons with regard to the processing of personal data and on the free movement of such
data, and repealing Directive 95/46/EC (General Data Protection Regulation), hereinafter referred to as GDPR,
the University of Warsaw informs as follows:

1. The University of Warsaw, with its seat in 26/28 Krakowskie Przedmieście, 00-927 Warsaw and
represented by the Rector, serves as the Administrator of your personal data.
2. The Administrator of personal data appointed the Inspector for Personal Data Protection, who supervises
the appropriacy of personal data processing, and who is available at e-mail address iod@adm.uw.edu.pl.
3. Your personal data shall be processed in relation with providing accommodation for you in Dom
Pracownika Naukowego in 9/11 Smyczkova Street, Warsaw 02-678.
4. Processing the data provided is necessary for the execution of the lease contract, whose party is the person
providing the data, or for initiating activities, at that person's request, prior to concluding the contract -
- Art. 6 Section 1 lit. b GDPR.
5. Providing your personal data is voluntary, however, your failure to provide them will result in our refusal
to offer you the service of accommodating you.
6. The data shall not be revealed to any third parties, excluding the cases stipulated by law.
7. Your data will be stored for consecutive 5 years:
- from the submission of application in case accommodation is not provided.
- from the lease contract expiry date or the date of moving out from the premises; with the 5-year period
commencing at the end of the calendar year when the abovementioned documentation is drawn up.
8. You are entitled to access your data stored, as well as to amend them or constrain the scope of their
processing.
9. You are entitled to make a complaint to the President of the Personal Data Protection in case you
recognise any breach of general provisions with regard to processing your personal data.
